Request: The applicant is requesting Annexation of approximately .36-acres compromised of two tax lot. The properties are designated Residential Mixed Density (C-RM) on the Comprehensive Plan Map and will be assigned a Residential Mixed Density (Z-RM) zoning designation upon Annexation.
