

## NOTICE OF PUBLIC HEARING LEBANON CITY COUNCIL

**NOTICE IS HEREBY GIVEN** that a public hearing will be held before the Lebanon City Council on **September 13, 2023 at 6:00 p.m**. in the Santiam Travel Station located at 750 S 3<sup>rd</sup> Street, to afford interested persons and the general public an opportunity to be heard and give testimony concerning the following matter:

Planning Case No.:	CPTA-23-01
Applicant:	City of Lebanon
Request:	Comprehensive Plan Amendment – Economic Opportunity Analysis
Decision Criteria:	Lebanon Development Code Chapters: 16.20 & 16.28

**Request**: Under consideration is a comprehensive plan amendment to formally adopt the Economic Opportunity Analysis. The applicant conducted an Economic Opportunity Analysis to evaluate the city's available lands for industrial and commercial development over a 20-year horizon, along with the goals and policies to support economic growth and business retention. The Analysis identified that there is sufficient land within the existing urban growth boundary with no required changes to the Lebanon Development Code needed.
