



GILLS LANDING CAMPGROUND

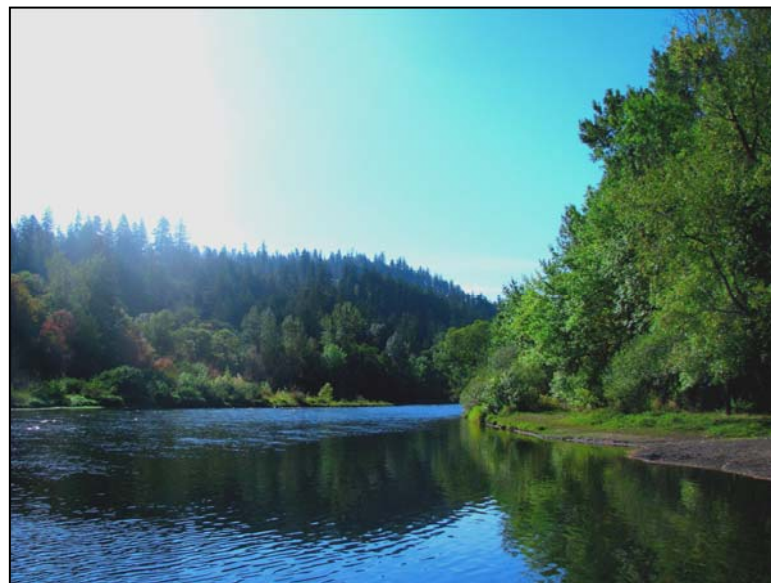
The Gill's Landing Campground has twenty-one concrete RV sites. Each site is surrounded by lush green grass and shares a panoramic view of the South Santiam River. All RV sites have 30,40,and 50-amp power supplies. Concrete Walkways provide easy access to the restroom and shower facilities. A short paved trail connects the campground with River Park and provides access to it's various number of special events.

-PARK RULES-

Lebanon parks shall be closed to access and use by members of the public between ten p.m. and seven a.m. Vehicles or patrons in park areas other than designated camping areas after ten p.m. will be asked to leave.

Failure to comply with any park rule may result in loss of camping and/or park privileges. This loss of privileges may be in addition to any civil or criminal charges that may arise from violation of these rules.

Loss of camping and/or park privileges may result for failure to keep camp sites and picnic areas clean and orderly at all times. Further campers shall be responsible for any damage they may cause as a result of negligent actions.

The sections below provide specific standards and/or restrictions for specific activities in parks and public places:

- A. Except as specifically allowed in [Section 12.12.050](#), camping or creating an established campsite is prohibited on any public space in Lebanon
- B. Length of Stay. Designated campsites may be reserved by a person or group for a period ten days in a four-week period. An extension may be granted by special permission of the director of public works (or designee)
- C. Designated Site Procedures. Check-out time for designated campsites is 12:00p.m. Check- time for designated campsites is 1:00p.m. Quiet hours are from 10:00p.m. to 7:00a.m.
- D. Alcohol and/or Drug Use. No person shall enter or remain in a park or public facility while in a visibly intoxicated condition. Refer to [Section 12.12.030](#) (alcohol in parks and public places) for specific alcohol use regulations.
- E. Animals. No person shall, within any city park, recreation area or other public space or way, unless within a designated dog park as established by the city, keep or permit in such area a dog or other animal, unless kept in a vehicle or on a leash. Persons keeping such animals shall also be responsible for the removal of any excrement left by their animals in any park, recreation area or other public space or way. Designated campsites shall be permitted two animals per site.
- F. Bicycle, Scooters, Roller Skates and Other Wheeled Vehicles Prohibited. No person, other than a police officer or reserve police officer in the furtherance of the officer's duty, shall ride or operate a bicycle, scooter, skateboard, roller skates or rollerblades upon benches, upon picnic tables, alongside or under picnic shelters or alongside or under gazebos located within any city park or recreation area open to the public, except upon park roads and designated bike trails within said parks or recreation areas.
- G. Digging. No person shall, within any city park or recreation area, or other public space or way, dig up or remove any soil, stones, rocks, or other substances whatever, without permission from the director of public works or their designee.
- H. Dumping. No person shall, within any city park or recreation area, or other public space or way, dump household or commercial garbage or debris brought from lands outside the park or recreational area.
- I. Fire and other heating sources. No person shall, within any city park or recreation area, or other public space or way, build, light or maintain any fire except in a stove, pit or fireplace especially designated for such purpose; however, portable gas, kerosene, propane, charcoal and oil-lamp stoves may be used within the park if in a safe operating condition.
- J. Littering. No person shall, within any city park or recreation area, or other public space or way, deposit any rubbish, garbage, glass, or other litter except in receptacles designated for that purpose.
- K. Parking. No person shall, within any city park or recreation area, or other public space or way, operate or park any truck, trailer, or other vehicle in any area other than an area specifically designed for such purposes. Designated campsites shall permit one vehicle in addition to the recreational vehicle, additional parking is available for an additional daily fee.
- L. Plants and Trees. No person shall, within any city park or recreation area, or other public space or way, pick, mutilate, dig or remove any plant, living or dead, or deface, mutilate, burn, destroy or defile any tree or plant within the limits of such area.
- M. Speeding. No person shall, within any city park or recreation area, or other public space or way, drive a vehicle at a speed greater than is posted.
- N. Vandalism. No person shall, within any city park or recreation area, or other public space or way, alter, deface, mutilate, or destroy any trail, road, parking lot, bridge, fence, building, sign, barrier or other facility or structure.
- O. No objects shall be driven into the ground (stakes, poles, posts, etc.) that could cause damage to underground utilities including irrigation systems.
- P. No person shall make, assist in making, continue, or cause to be made any boisterous, disturbing, threatening, abusive, indecent, or obscene language or gestures or unnecessary noise; or by any other act to breach the public peace; or annoy, disturb, injure, or endanger the comfort, repose, health, safety, welfare, or peace of others while in any park or public facility.
- Q. No person shall smoke in a city park. Exceptions: Camping; Smoking shall be permitted in all specifically designated campsites

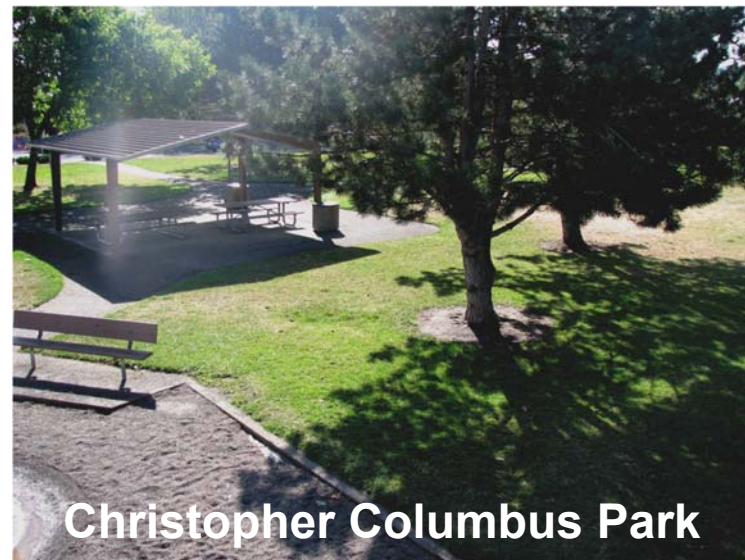
